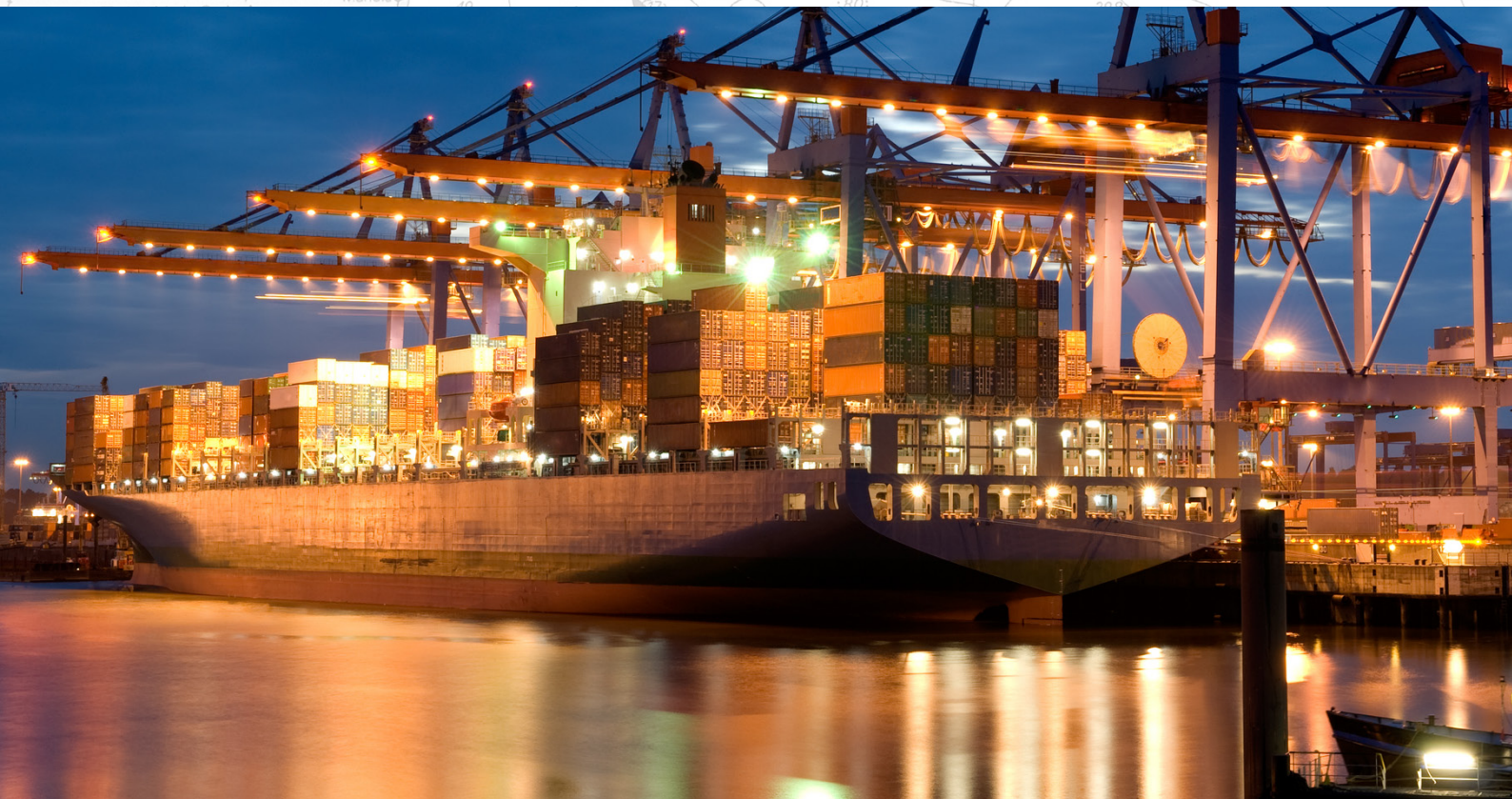


COMPANY PROFILE

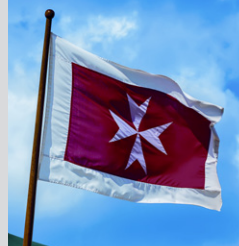
